

A guide to your Water Usage Report Macalister Irrigation District

Your Water Usage Report provides up-to-date information about your water shares (high and low reliability), current available allocations, and water

usage details.

They are available from SRW's online water ordering centre at www.srw.com.au/worder or by contacting your planner on 1300 360 117.

To access your Water Usage Report online follow the instructions below:

1. go to www.srw.com.au/worder
2. Enter your allocated user and pin number. If you do not know your user and pin number, contact our customer service centre on 1300 139 510
3. Select "Usage" from the top menu, then select "Allocation"
4. All of your services will be listed on the screen. Select "View Statement" on the right side for the services you wish view.

An explanation of your Water Usage Report as it appears on the screen is shown overleaf.

How to read your Water Usage Report

Allocation bank account associated water share details

Details your total high and low reliability water shares.

Note: This is your allocation, not the total amount of water you have available.

Usage details

Actual usage – based on you last meter readings

Estimate usage – based on your orders since the last meter reading

Sum of usage – actual and estimated usage

Annual allocation details

- Current available water allocation – both high and low reliability
- Water traded in and out of your allocation bank account (ABA)
- Spill entitlement – this figure may vary after your meter readings are entered. Usage is based on ordered estimates and meter readings of each outlet

Total allocation

Total water allocated to date

Total allocation remaining

Equals "Total Allocation" minus "Sum of Usage"

Meter readings

Your outlet number/s & meter readings as at the date of the report

Order details

Your order details for the season excluding cancelled orders

Associated water use licence

- Water Use Limit – calculated by your old Water Right x 1.68 plus domestic and stock entitlement – or the greatest volume of water used on that parcel of land since 1998/99
- Delivery against Licence – Water delivered through each outlet

Associated delivery shares

- Annual Delivery Allowance – equals your daily delivery share multiplied by the length of season (270 days)
- Delivery against Allowance – water delivered through each outlet

Delivery share distribution

Your available share of the delivery system.
