# Variation of 26 November 2021 orders staying original directions

Order 2 of the Tribunal's order in proceeding P1179/2021 dated 26 November 2021 is amended to read:

Pursuant to section 50(5) of the *Victorian Civil and Administrative Tribunal Act 1998*, and subject to further order, the stay order in Order 1 (above) will be lifted:

- (a) Before 30 June 2022, if the water level in Pintail Dam on the land at 1075 Horseshoe Bend Road, Torquay exceeds RL 12 metres AHD as referenced against the datum on the site plan in the report of Australian Geotechnical Testing, numbered AGTE17463, December 2017 ('AGT Report'); and
- (b) After 30 June 2022, if the water level in Pintail Dam on the land at 1075 Horseshoe Bend Road, Torquay exceeds RL 9.5 metres AHD as referenced against the datum on the site plan in the AGT Report.

## **PROCEEDING P11797/2021**

## Leave to amend application

- The applicants in proceeding P11797/2021 are granted leave to, by **1 August 2022**, file and serve an amendment of their application, under section 67 of the *Water Act 1989*, for a licence (No ANJW1624119 amended application) to alter the works (constituted by Pintail Dam) to decrease the holding capacity of Pintail Dam to RL 9.5 metres AHD, as referenced against the datum on the site plan in the AGT Report by the removal of a section of the eastern wall down to RL9.5 metres AHD including provision for:
  - (a) a minimum width of 5m for the section of the wall proposed to be removed;
  - (b) the slope of the batter on either side of the removed section of the wall such that the safety and stability of the remaining wall is ensured and maintained; and

- (c) drainage works which, in the event of any flow from Pintail Dam (whether by reason of overfilling or failure of pumps or other infrastructure), will direct the flow of water away from the nearby residential and other properties.
- 7 The amended application must be supported by (as appropriate):
  - (a) geotechnical, and other engineering, reports;
  - (b) a risk assessment, including an appropriate piping failure risk assessment assessed against the ANCOLD tolerability criteria for existing dams; and
  - (c) detailed demolition and construction plans.
