# **Acknowledgement to Country**

Southern Rural Water acknowledges and recognises Aboriginal people as the Traditional Owners and Custodians of the land and waters on which we work and live and we respect their deep and ongoing connection to Country.

### **About Southern Rural Water**

Southern Rural Water (SRW) is proud to be the lifeblood of the agricultural economy of southern Victoria. With assets valued at \$2.1 billion, our irrigation districts deliver water from catchment to farm gate. As regulators of surface and groundwater, we provide fair, equitable and sustainable access to water resources. Our services support farmers to generate high quality, fresh and local produce, much of which ends up on tables across the globe ready to be enjoyed by consumers.

We supply water to irrigators, power generators, urban water corporations and we work with the Victorian Environmental Water Holder alongside Catchment Management Authorities and Melbourne Water to manage the release of environmental flows.

We service an area of 88,000 square kilometres, stretching from the South Australian to the New South Wales border and from the Great Dividing Range to the Victorian coastline.

We operate seven major dams, eight diversion weirs, three irrigation districts and manage take and use licences for waterways, licences relating to catchment dams and farm dam registration.

We recognise the important role we play as stewards of water resources, ensuring that we manage them sustainably for the long term.



### Introduction

The purpose of this Blue Rock Lake Recreational Area Management Plan ('the plan') is to provide clear guidelines for managing recreational activities at Blue Rock Lake while minimising impacts on water quality, the environment, and SRW assets and operations.

The plan provides a comprehensive and practical framework for SRW to manage recreational activities at Blue Rock Lake in a way that protects the natural environment, maintains water quality, and supports the safe enjoyment by visitors.

Key values referenced in the development of the plan include:

- Environmental protection
- · Recreational opportunities
- Cultural heritage
- · Economic benefits, and
- Community engagement.

The plan details permitted recreational activities, management objectives, designated set aside areas to balance use and conservation, and highlights the variety of stakeholders involved in the management of Blue Rock Lake. Further, the plan references the Department of Energy, Environment and Climate Action's (DEECA) guidance materials to ensure sustainable use and the protection of water resources.

### Recreational Area Management Plans (RAMPs)

The Water (Recreational Area) Regulations 2023 ('the Regulations') apply to approximately 40 water storages across Victoria. These storages have been determined as recreational areas by the Minister for Water in accordance with section 122ZA of the Water Act 1989.

The Regulations provide for the control, management and use of recreational areas, as well as provide for infringement offences and penalties. These infringement penalties were not available in the superseded Recreational Area Model By-law 2012. The Regulations came into operation on 19 August 2023, replacing SRW's Recreational Area By-law.

A key feature of the Regulations is the requirement for Water Corporations to develop management plans for recreational areas under their management. These plans support the control, management and use of recreational areas and provide for the ability to identify infringement offences and penalties.

In addition to the Regulations, SRW manages the recreational use of this storage in accordance with:

- Water Act 1989;
- Marine Safety Act 2010; and
- Safe Drinking Water Act 2003.

The plan serves as a guiding document for SRW, local communities, and stakeholders in managing recreational activities at Blue Rock Lake.

It provides clear guidelines and actions to enable the sustainable use of the Blue Rock Lake recreational area while protecting its natural and cultural values.

It is intended to be a living document, to be reviewed and updated when appropriate based on the monitoring of recreational activities and in consultation with key stakeholders.

#### **About Blue Rock Lake**

Blue Rock Lake is located near the township of Willow Grove in Victoria's Baw Baw Shire, approximately 140 kilometres east of Melbourne. Its proximity to towns like Moe and Traralgon makes it a convenient destination for residents of Gippsland and Melbourne seeking recreational activities and relaxation.

Constructed between 1979 and 1984, Blue Rock Lake was developed to supply water to the Latrobe Valley for industrial, irrigation, and domestic purposes. With a storage capacity of 208,000 megalitres, it serves as a crucial water source for power generation, urban consumption and environmental flows in the region.

The lake features two main recreational areas—Spillway Road and Old Tanjil Road—offering facilities such as picnic tables, electric barbecues, toilets, and designated swimming zones. Visitors can enjoy activities like boating, kayaking, swimming, and fishing. Notably, Blue Rock Lake is recognized as one of Victoria's premier fisheries for Australian bass, with other species like trout and redfin also present.

While camping is not permitted around the lake, the surrounding area provides ample opportunities for day trips and outdoor recreation, making Blue Rock Lake an ideal spot for families and nature enthusiasts alike.

# Objectives of the Plan

The objectives of this management plan for recreational areas at Blue Rock Lake are to:

- Protect the land, services and facilities in the area;
- Protect and maintain water quality in waterways in the area;
- Conserve and preserve flora, fauna and habitat in the area, including the biodiversity of that flora, fauna and habitat;
- Protect the health and safety of visitors to the area;
- Promote the enjoyment and recreation of visitors to the area;
- Protect and promote Aboriginal cultural heritage and Aboriginal intangible heritage in the area;
- Protect and promote any other heritage features in the area;
- Facilitate the participation of Traditional Owner groups in the management of the area, including in accordance with any agreements under the *Traditional Owner Settlement Act 2010* that apply to the area;
- Ensure that the area is managed and used in a way that respects and upholds the rights and aspirations of Traditional Owner groups who have a connection to the area.

SRW adopts in full the objectives specified within Regulation 7 of the *Water (Recreational Area) Regulations* 2023.

### **Traditional Owner Rights and Participation**

This plan has been developed in full recognition and support of Traditional Owner rights to self-determination. It welcomes input outside western frameworks, respecting the time and decision-making processes of the Traditional Owners of the land encompassing the Blue Rock Lake, being the Gunaikurnai people. To minimise pressures surrounding cultural load, a review of the plans can be initiated by the Registered Aboriginal Party (RAP) groups at any time under the Regulations.

Water corporations are subject to agreements under the *Traditional Owner Settlement Act 2010* and the *Native Title Act 1993*. This includes commitment to work in partnership with relevant Traditional Owner

groups. The Regulations provide for the incorporation of policy and legal frameworks that recognise Traditional Owners' rights recognised under these Acts.

### Location

#### **Blue Rock Lake**

Blue Rock Lake is situated on the Tanjil River near the township of Willow Grove in Victoria's Baw Baw Shire, approximately 140 kilometres east of Melbourne. Completed in 1984, the lake serves as a vital water storage reservoir supporting power generation, agriculture, and domestic water supply in the Latrobe Valley region.




Figure 1: Blue Rock Lake Location Map. Source: Google Maps

Figure 1 illustrates the broad location of Blue Rock Lake.

#### **Blue Rock Lake Recreational Facilities Area**

The Blue Rock Lake Recreational Area generally comprises the following areas/facilities:

- Two (2) Boat ramps.
- Two (2) jetties.
- Formal and informal car parking with space for trailers.
- Amenities blocks.
- Uncovered seating areas.
- Covered seating areas.
- All-abilities children's playground (Blue Rock Lake Eastern Recreational Area only).

The lake features two main recreational areas: Spillway Road (Eastern Recreational Area) and Old Tanjil Road (Western Recreational Area), offering a well-maintained natural setting for a range of outdoor activities.

Facilities include picnic tables, electric barbecues, toilets, and designated swimming zones. Visitors can enjoy activities such as boating, kayaking, swimming, and fishing. Notably, Blue Rock Lake is recognized as one of Victoria's premier fisheries for Australian bass, with other species like trout and redfin also present.

Boating is permitted on the lake, with a maximum speed limit of 15 knots, except in designated safety zones where a 5-knot limit applies. There are two boat ramps available for public use, located at Spillway Road and Old Tanjil Road.

While camping is not permitted around the lake, the surrounding area provides ample opportunities for day trips and outdoor recreation, making Blue Rock Lake an ideal spot for families and nature enthusiasts alike.

### **Recreational Activities**

Public recreational areas managed by SRW are popular places for visitors to connect with the natural environment, and to undertake a variety of recreational activities. SRW places the highest priority on safety at the storages we manage.

Prohibited activities generally pose a risk to water quality, the environment, cultural heritage and to public safety. Any activity that is not specifically listed in this Section should be considered as prohibited, unless permission is explicitly granted by SRW. All activities must be generally in accordance with the *Water* (Recreational Area) Regulations 2023.

Visitors must follow all instructions indicated on any official signage in and around the recreational areas.

The removal, replacement, damaging or harm to any native flora or fauna, or any cultural heritage is prohibited.

Table 1 below summarises the activities permitted and prohibited, including any applicable conditions, at Blue Rock Lake Recreational Area.

Power boating	~	Only boats powered by an internal combustion engine are permitted if the engine has a water-cooled exhaust system, discharging through the transom at or below waterline.
		Powered boats are not allowed within the area generally shown in Figure 6, or otherwise as restricted via the use of buoys within recreational areas and surrounds.
		As signalised and as defined in Figure 7, a person must not operate a vessel exceeding the maximum speed of 5 knots (within safety zones defined in Figure 6) or 15 knots otherwise.
		Vessels (including Jetskis) are not allowed on the water without displaying current registration and drivers carrying a current marine license, and may be inspected for appropriate equipment.

# **Water Safety**

SRW places the highest priority on safety at the storages we manage. Ensuring personal safety and adhering to posted guidance can help prevent accidents and ensure a safer experience for everyone.

Key themes are aimed at educating recreational users and reducing risk taking behaviours and include:

- Speed;
- Lifejackets;
- Boating alone;
- Checking conditions;
- Hazard awareness;
- Consumption of alcohol; and
- Diving.

## **Swimming**

SRW storages are not patrolled by lifeguards nor contain rescue equipment.

Therefore, visitors are encouraged to wear life jackets, not swim alone and should make themselves aware of the local dangers (associated with alcohol consumption, diving, etc.) and other risks, such as submerged objects, varying water depths and water temperature, before entering the water.

Children must be supervised at all times.

## **Boating Safety**

When using the waterway, boaters need to be aware of the vessel operating and zoning rules, including supportive signage and buoyage in place. Please refer to relevant restrictions defined in Figures 6 & 7.

While in many instances there are state-wide rules in place, there are also localised zoning rules that can vary across the waterway.

#### **Set Aside Areas**

To accommodate the diverse range of recreational activities that occur at Blue Rock Lake, SRW may use 'set aside areas' to enable flexible or tailored management of the area, or part of an area, under the Regulations while ensuring the health, safety and enjoyment of visitors.

Regulation 14 (3) specifies that an Authority may 'set aside' any area for any activity not otherwise specified in the Regulations as permitted, restricted or prohibited. This occurs if the Authority considers this is necessary and consistent with the management plan for a recreational area, including its objectives and procedures.

#### **Publishing a Determination of a Set Aside Area**

A determination of a set aside area will be published on the SRW website and there will also be signs and notices placed on-site to demarcate the area, as far as practicable.

It is an offence not to comply with the conditions of determinations in set aside areas. If SRW revokes or amends a set aside area, any previous sign or notice that has been displayed under the Regulations must be removed or amended to reflect the revocation or amendment.

#### Signage for Set Aside Areas

Signs or notices will:

- Be displayed in a manner that is likely to be seen by any person affected by the determination;
- Indicate the area that is temporarily closed or set aside by the determination; and
- Where applicable, state the activities that are prohibited, restricted or permitted by the determination and any conditions specified in the determination.

#### **Blue Rock Lake Set Aside Areas**

At Blue Rock Lake:

- Prohibited areas, as defined by fencing and signage within the recreational areas or their surrounds must not be entered;
- Access to the public can only occur within the operation hours of 8am 8pm daily;

- Camping or stay overnight are prohibited activities;
- All fires, including for picnic and barbequing purposes are prohibited;
- Reserve of picnic areas is prohibited unless otherwise consented by SRW;
- Driving or riding motorbikes along the shoreline or within fenced areas is prohibited;
- Hunting and carrying or discharging a firearm are prohibited actions;
- Undertake any dangerous activity is prohibited;
- No animals other than dogs are allowed, unless expressly permitted by SRW;
- Littering, vandalising or undertaking any dangerous activity are strictly prohibited actions.
- Boating rules and restrictions apply, generally as illustrated in Figures 6 & 7.

For more details about prohibited actions or activities, please refer to Table 1 and Figure 6 & 7 of this plan.

#### **Prohibited Areas**

There is no public access outside the hours of 8am – 8pm daily or unless otherwise restricted within recreational areas or their surrounds via fencing signage or as defined in Figure 6.

# **Temporary Closures**

Temporary closures of SRW recreational areas may occur on occasion as outlined in the Regulations.

A temporary closure will generally and primarily occur to:

- Support the safe management of events such as floods and fires;
- Allow for operational or maintenance works to take place;
- Manage amenities and access during periods of low water levels;
- Manage safety during periods of high water levels;
- Rationalise maintenance requirements during times of low visitation; and
- Manage safety during water quality events such as algal blooms.

In the event of an immediate temporary closure, SRW will:

- Publish the determination of a temporary closure on the SRW website and promote it through social media; and
- Where possible, display signs or notices on-site providing details of the temporary closure determination.

Any temporary closures will be communicated with impacted parties by SRW as soon as practicable, in accordance with the Regulations.

### **Events and Permits**

#### **Events**

From time to time, people wish to hold events at our recreational facilities including festivals, birthday parties and weddings. We cannot close our recreational facilities for private events, and you cannot book sites.

You must have permission to hold any organised entertainment, rally, boating event or regatta, festival, public meeting, training class or demonstration, wedding or similar ceremony, or private functions for 30 or more people.

#### **Permits**

Under the Regulations, water corporations may issue permits to provide for the effective, proactive and appropriate management of activities within recreational areas. The permit system outlined in the Regulations provides a framework where a person can apply to enter and use a recreational area, or an area within a recreational area, for a specified purpose and for a specified period.

Permits can be provided for the following activities under the Regulations:

- Enter the area at a time during which it is closed for public access (r.23(2));
- Access to a temporarily closed recreational area (r.29(2));
- Remain in a prohibited access area (requires express permission) (r.36(1));
- Remain in a restricted access area (requires express permission) (r.36(2)(b));
- Possess or use a restricted item in a recreational area (r.38(5));

- Behave in a manner that causes, or is likely to cause, a nuisance to any other person (requires express permission) (r.39(2)(b));
- Operate a sound producing device or any other equipment in a recreational area (r.41(4));
- Light or maintain the fire in a recreational area during a period in which there is no fire restriction in force for that area (requires express permission) (r.42(2)(d));
- Disturb, remove or cause any harm to fauna in a recreational area (requires express permission) (r.46(5)(b));
- Undertake timber harvesting operations (r.47(2)(b));
- Move, remove or cause damage to flora or other vegetation in a recreational area (requires express permission) (r.47(2)(c));
- Damage, destroy or remove a rock in a recreational area if the person has express permission to damage or destroy rocks in, or remove rocks from, a recreational area (requires express permission) (r.50(3));
- Dig into or remove the ground or ground cover from a recreational area, or bring any ground or ground cover into a recreational area (requires express permission) (r.51(3)(a));
- Bring an animal other than a dog, a horse or livestock into, or allow any such animal to enter and remain in, a recreational area (r.54(3));
- Allow an animal to enter and remain in a recreational area (under licence) (r.55(2)(a));
- Bring a dog into an area within a recreational area where dogs are prohibited (r.56(4));
- Bring a horse into, or allow a horse to enter and remain in, a recreational area (r.60(4));
- Bring livestock into, or allow livestock to enter and remain in, a recreational area (r.62(4));
- Erect or install a temporary or permanent structure in a recreational area (r.64(6));
- Enter, occupy or use a building or structure in a recreational area (r.65(3));
- Damage or destroy a temporary or permanent building or structure in a recreational area (r.66(4));
- Conduct an event in a recreational area (r.68(3)) (for example: entertainment, sporting or recreational event or show, rally, an organised boating event or regatta, a festival, tour, fete or public meeting, a demonstration, training class or other event, a wedding or celebration of civil union ceremony or event or a private function for 30 or more persons);
- Conduct a commercial activity in the recreational area (r.69(4));
- Make a commercial recording in the recreational area (film or audio, or radio broadcasts) (r.70(4));
- Soliciting money or collecting money, erecting a sign for the purpose of advertising, handing out or disseminating advertising, commercial or promotional material and delivering an address (r.71(6));
- Camp in the recreational area (r.74(4));
- Cause the vehicle, vessel or aircraft to enter the recreational area (requires express permission) (r.79(2)(b));
- Refuel a vehicle or vessel in the recreational area (requires express permission) (r.81(2)(d));
- Sink or scuttle a vessel, jetty or pontoon, or carry out the salvage of a sunken vessel, jetty or pontoon in a recreational area (r.90(3));

- Camp overnight on a vessel in the recreational area (requires express permission) (r.94);
- Launch or land an aircraft or a remotely piloted aircraft or deliver a thing by an aircraft or a remotely piloted aircraft in a recreational area (requires express permission) (r.95(4)(b)).

Please review the Regulations for details of each permit if/as applicable.

Please note using and developing land may require other permits under legislation other than the Regulations. Proponents are responsible for compliance with all of their statutory obligations.

Express Permission

In some cases, the Regulations permit activities via 'express permission'. Express permission can be granted by permit, lease or licence. Express permission can also include a contract or other agreement, or any other authorisation provided for under the *Water Act 1989*. This may include written agreement.

Under the Regulations, permits must remain in the holder's possession while engaging in the permitted activity or accessing an area authorised by the permit and produce the permit for inspection if requested to do so.

Permits can be varied or cancelled by either the holder or water corporation, and the water corporation can cancel a permit immediately as outlined in Regulation 19.

Permits and set aside areas can be used together or separately – to provide broader, more proactive management of these activities within recreational areas.

# **Compliance and Enforcement**

The Water (Recreational Area) Regulations 2023 introduced the ability for SRW to issue Penalty Infringement Notices (PINs) for offences under the Regulations.

Water corporations can issue PINs to users undertaking activities that are in breach of the Regulations. These include activities that may risk land and water services, water quality, the environment, or the health, safety and enjoyment of other users within a recreational area.

# **Monitoring and Evaluation**

This plan will be reviewed every 10 years, or sooner as needed, to assess its effectiveness and make any necessary adjustments. This review process will involve:

- Traditional Owner engagement and an open feedback process based on the principles of selfdetermination;
- Monitoring and Evaluation: Regularly monitoring the impact of recreational activities on the environment and water quality;
- Regulatory Compliance: Ensuring compliance with DEECA's guidelines and other relevant regulations;
- Community Feedback: Gathering input from local residents, recreational users, local government authorities (LGAs), special interest groups and other key stakeholders.

#### **Development Aspirations**

#### **Eastern Recreational Area**

• (High Priority) Spillway Roadway Safety Works (Near Eastern Recreational Area) – Introduction of non-permanent traffic calming devices and pedestrian refuge space along Spillway Roadway. This will create safer spaces for pedestrian and cyclists using this road/space, currently subject to high speed driving.

- Signage Maintenance and Simplification: Signage in the Western Recreational Area is in poor condition and requires attention, whereas signage in the Eastern Recreational Area is excessive near the boat ramp.
- Boat Ramp Upgrade (In Western Recreational Area) To widen the existing platform making it more accessible to users and avoiding damage of vehicles/vessels at drop offs.
- Play Equipment Upgrade (In Western Recreational Area) Introduce nature-based or water-themed play spaces to attract and accommodate families with young children, improving the site's family-friendly appeal.
- **Lighting Installation on Key Areas** Install solar-powered lighting in high-use zones such as car parks, picnic areas, walking paths, and boat ramp to enhance safety during early morning or evening use, particularly in winter months.
- **Solar Panel Expansion** Expand any existing solar infrastructure to sustainably support new lighting and potential future amenities, aligning with environmental objectives.
- Fishing Platforms At key locations where fishing does not interfere with other activities present onsite.
- Water drinking Facilities Installation To encourage hikers and cyclists to visit and use this Recreational Area.
- CPTED (Crime Prevention Through Environmental Design) Enhancements Improve safety and usability by:
  - Re-landscaping to increase visibility and open sightlines.
  - Using transparent or open-structure shelters.
  - Repositioning picnic tables and other amenities to high-visibility areas.
  - Erecting perimeter or access-control fencing where needed.
  - Installing informative and regulatory signage.
  - Encouraging local community murals or artworks to foster a sense of ownership and deter vandalism.
