Licence to Take and Use water, Operate or Construct works

This form combines the requirements to transfer ownership of a take and use licence (*Sections 51 & 62 Water Act 1989*) and a licence to operate or construct works (*Section 67 & 74 Water Act 1989*) upon sale of land. All other licence details will remain the same.

SRW must inspect the completed installation for compliance to standards and specifications. All meters remain the property of SRW.
